1. Main Activities During Reporting Period

- a. Remedial Action Plans (RAPs) for PCB soil remediation on Parcel A and Parcel B resubmitted to supersede the previously submitted PCB soil RAPs.
- b. Soil remediation and Station B Demo currently out to bid.
- c. Scope of Study for Eastern Portion of English Station Interior Boilers 1 through 12 re-submitted containing only environmental media.
- d. Scope of Study for English Station Main Building High Pressure Boilers 13 & 14 continues submitted.
- e. Remedial Action Report for scabbling activities in Station B submitted to CT DEEP and EPA
- f. TRC performing sampling of environmental media and hazardous building materials within Western Portion of English Station.
- g. TRC performing sampling of environmental media within the Eastern Portion of English Station Boilers 1 through 12.
- h. Developed final version of Scope of Study: English Station Eastern Interior Boilers 1 through 12 and High Pressure Boilers 13 and 14 for hazardous building materials.
- i. TRC performed bi-weekly inspections of the Significant Environmental Hazard (SEH) areas and prepare inspection reports.
- j. Weston & Sampson tabulating 3rd quarter groundwater sampling
- k. Management of State and Federal regulated waste during site activities.
- 1. UI English Station Project team met with City of New Haven at the monthly Utility Coordination meeting to begin discussions on permitting needs.
- m. Community Outreach Website will be updated with the Main Activities during Reporting Period and Upcoming Activities sections of this document.

2. Upcoming Activities

- a. TRC will continue to sample environmental media and hazardous building materials inside of English Station
- b. Continue to work with internal departments on next step actions for the bid on soil remediation and Station B demo for the project.
- c. Work with EPA and CT DEEP on Remedial Action Plans for the PCB remediation on Parcels A and B.
- d. Submit the Scope of Study for English Station Eastern Interior Boilers 1 through 12 and High Pressure Boilers 13 & 14 on hazardous building materials.

- e. Begin sampling activities of sediments, solids and liquids within the footprint of the main power plant of English Station and associated discharge tunnels.
- f. Perform fourth quarter of groundwater sampling.
- g. Continue to work with the City of New Haven on the permitting needs for the upcoming Soil Remediation and Station B Demo work
- h. Evaluate off-site sources for suitable soil borrows for fill needed to implement remedial actions at the site.
