1. Main Activities During Reporting Period.

- a. Developing the following Project related documents for submittal to CTDEEP
 - i. English Station Boiler 13 Mat Foundation Scope of Study
- b. Provided the following Project Related documents to CTDEEP
 - i. Approval of (re)Registration Under CTDEEP-BMMCA General Permit DEEP WPED-GP-015
- c. Continue to work with the State of Connecticut along with Property Owner(s) of Parcel A & B (*and as necessary, the developer*) to obtain signatures/acceptance on the current approved RAPs pursuant to requirements in the CTDEEP and EPA approval letters
- d. Continue to work with CTDEEP and EPA on the review, comment and approval on the Phase I - Parcel B PCB RAP (*pertaining to soil remediation*)
- e. Continue to work with AVANGRID Procurement to execute the following:
 - i. Phase I Soil Remediation
 - ii. English Station Boiler 13 Interim Remedial Measure
- f. Continue to refine overall Project schedule and cost estimate(s)
- g. Perform required stormwater inspections of the site erosion and sediment controls for the Phase I activities approved under CT DEEP permit number GSN003422.
- h. Perform bi-weekly inspections of the Significant Environmental Hazard (*SEH*) areas
- i. Work with AVANGRID internal stakeholders to develop format for upcoming public information session on Project
- j. Updates to UI's English Station Project website.

2. Upcoming Activities

- a. Submit to CTDEEP
 - i. English Station Boiler 13 Mat Foundation Scope of Study
- b. Work with State of Connecticut on obtaining property owner's signature/acceptance for current approved Parcel A PCB RAP and Non-PCB Soil RAP (Parcel A&B)
- c. Continue to work with EPA and CT DEEP on the authorization of the Phase I - Parcel B PCB RAP

- d. Commence certain Phase I soil remediation ancillary activities covered in the Phase I RAPs, pending owner acknowledgement letter and other applicable approvals:
 - i. Evaluate off-site sources for suitable soil/clean fill to be used as cover material for site-wide restoration.
 - ii. Sample debris piles on both Parcel A & B.
- e. Pursuant to the sequence of approvals from CTDEEP, perform supplemental environmental media sampling inside of English Station (*Western Side, Boiler 1-12, & Boiler 13/14*)
- f. Continue to work towards finalizing the following procurement packages
 - i. Phase I Soil Remediation
 - ii. English Station Boiler 13 IRM
- g. Work with CT DEEP on any follow-up comments for the following documents
 - i. Scope of Study for English Station Eastern Interior Boilers 1 through 12 and High Pressure Boilers 13 & 14 (*hazardous building materials*)
 - ii. Scope of Study for English Station Eastern Interior Boilers 13/14 (*environmental media*)
 - iii. Supplemental Scope of Study for English Station Eastern Interior Boilers 1 through 12 (*environmental media*)
 - iv. Debris Pile Sampling Memo
 - v. Phase I Plans and Specifications
- h. Work with CT DEEP on Project schedule and scope
- i. Continue to refine Project estimates for Main Power Plant
