 - d. Began developing (data) summary report and Parcel A PCB Remedial Action Plan (RAP) modifications for the results obtained from the South Tunnel (Situation #3) sampling event.

 - f. Based on discussions with CTDEEP, the Phase I Plans and Specifications have been re-aligned to match current approved RAPs.

 - j. Continue to refine overall Project schedule and cost estimate(s) associated Main Power Plant scope.
 - k. Work through AVANGRID Procurement process to identify a contractor for the soil remediation activities on Phase I.
 - 1. Perform required stormwater inspections of the site erosion and sediment controls for the Phase I activities approved under CT DEEP permit number GSN003422.
 - m. TRC performed bi-weekly inspections of the Significant Environmental Hazard (*SEH*) areas and submitted inspection reports to UI.
 - n. Updated of Project Website.
